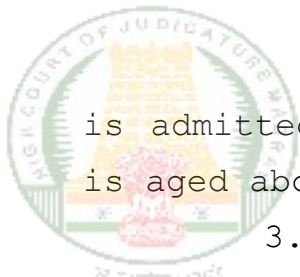

Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.G.MOHANKUMAR, Advocate for the petitioner and of M/S.K.SUYAMBULINGA BHARATHI, Government Advocate (Crl.Side) on behalf of the Respondent, and M/S.R.SUNDAR, intervenor for the Respondent, the court made the following order:-

This petition has been filed to relax the condition imposed on the petitioners in Crl.O.P.(MD) No.138 of 2018, dated 17.01.2018.

2.The learned counsel appearing for the petitioners submitted that the petitioners are complying with the condition from 31.01.2018 without any deviation. As of now, the fourth petitioner

3.This Court heard the submissions of the learned Government Advocate (Criminal side) on the abovesaid submission.

Insofar as the petitioners 2 and 3 are concerned, this petition is dismissed.
