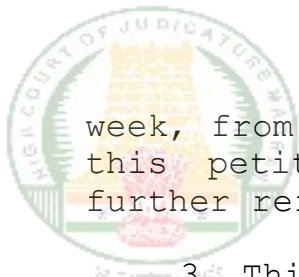
PRAYER IN CMA(MD) No.SR21944 of 2015:-
