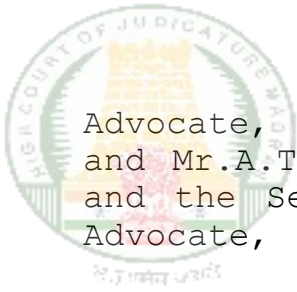
Prayer in CMP(MD) No.5029 of 2016:
