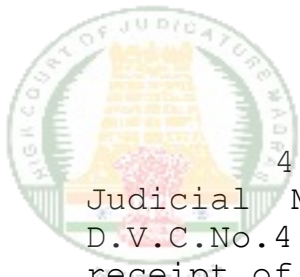

The learned counsel for the petitioner has submitted that the respondent herein has filed an application under Section 12 of the Protection of Women from Domestic Violence Act, 2005 and the same has been taken on file in D.V.C.No.4 of 2017 by the learned Judicial Magistrate, Padmanabhapuram.
