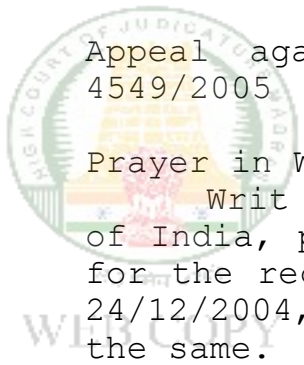

Prayer in CMP(MD). 5644/ 2016 in WA(MD). 112/ 2011 :

To condone the delay of 264 days in filing the above petition and thus render justice.

Prayer in WA(MD). 112/ 2011 :

The appellant above named preferred this Memorandum of Writ Appeal against the order dated 13.11.2009 made in WP.(MD).No. 7173/2007

Prayer in WP(MD). 7173/ 2007 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus, calling for the records relating to the order made in Na.Ka/B3/28478/05 dated 11/01/2007 passed by the 2nd respondent and quash the same and consequently direct the respondents 2 and 3 to continue the distraint proceedings ordered in certificate in Rc.E1/84370/04 dated 24/12/2004 issued by the 1st respondent to recover the dues from the 4th respondent under the Revenue Recovery Act by auctioning the property comprised in S.F.No. 483/33, sub Division, S.F.No. 483/68 in patta no. 1637, situated at Door. No. 6/2-40 LF road, Kanadukathan Village, ward no. 6, Karakudi Taluk, Sivagangai District
