Prayer in CRL OP(MD). 3370/ 2018 :

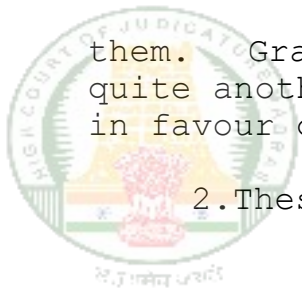

These petitions have been filed to cancel the bail granted in favour of the accused. It is seen that the accused were in jail for more than 27 days. It does not appear that the accused after grant of bail, abused the liberty or misused the conditions imposed on



them. Granting of bail is one thing and cancellation of bail is quite another. No case has been made out to cancel the bail granted in favour of the petitioners.
