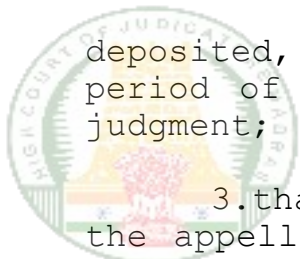
Decree:
