ORDER

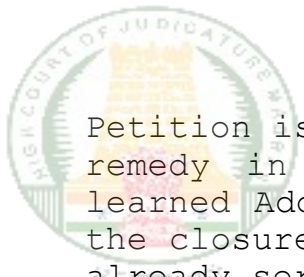
This petition has been filed to direct the 2nd respondent to register the petitioner's complaint, dated 15.12.2016.
