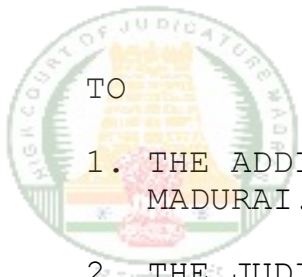
2.Though notice has been served on the respondent, none appeared on his behalf either in person nor through his counsel.
