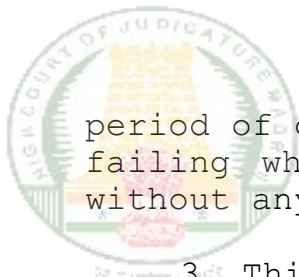

This petition has been filed to condone the delay of 403 days in filing the above Civil Miscellaneous Appeal in CMA(MD)No.sr29697 of 2017, against the award passed in M.C.O.P.No.152 of 2004.

Considering the reasons stated in the affidavit filed in support of the petition and also considering the length of delay, this Court is inclined to condone the delay, subject to the payment of cost of RS.1,500/- (Rupees One Thousand and Five Hundred only) to the Legal Aid Service Authority, attached to this Bench, within a
