This Review petition has been filed by the appellants in W.A. (MD)No.421 of 2014 to review the Judgment dated 27.06.2017

2. We have heard Mrs.Srimathi, learned counsel appearing for the review petitioners and Mr.N.Dilip Kumar, learned counsel appearing for the respondents.

3. After hearing the submissions of the learned counsel for both sides at considerable length, we find that this case is squarely covered by the recent decision of the Division Bench of this Court in **Government of Tamil Nadu Vs. J.Remila in WA (MD) No. 1350 of 2017 dated 14.11.2017** wherein identical issues, more particularly grounds raised in 5, 6, 7 of the review petition were rejected by Division Bench of this Court in the said Judgment. Thus, we find no grounds have been made out for reviewing the order. That apart in the grounds of review it is not pointed out as to what are the errors apparent on the face of the Judgment warranting us to review the same.

4. Hence, we are not inclined to entertain this Review Application and accordingly the same is dismissed. No costs.
