Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus calling for the records pertaining to the impugned order passed by the 6th respondent in Na.Ka.A3/4373/2015, dated 15.09.2015 and the order passed by the 5th respondent in Na.Ka.A4/1502/2013, dated 21.09.2015, quash the same and direct the respondents 1 to 7 to direct the respondents 8 to 13 to remove the encroachment made by them in 17th and 18th Cross Roads of Vasam Nagar, South Extension in S.Nos.80/2, 80/3 and 80/4 abutting the petitioners lands in S.Nos.8C/6 and 84/1A of Nachikurichi village, Srirangam Taluk, Trichy District.
