O R D E R

This petition has been filed to quash the proceedings in C.C.No.186 of 2015 on the file the Judicial Magistrate No.II, Srivilliputhur.

2.The learned Government Advocate (Crl. Side) would submit that the trial has been commenced and PW1 to PW3 were examined before the trial Court.

3.It is seen from the records that no ground is raised by the learned counsel for the petitioner to quash the criminal proceedings against him.
