**PRAYER IN CMA(MD) No.SR31073 of 2016:**

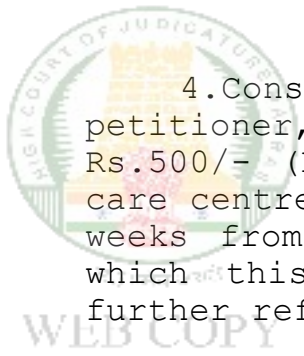
