ORDER

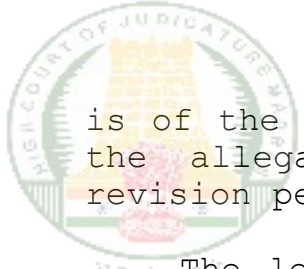
This civil revision petition has been filed by the revision petitioner / plaintiff, seeking a direction to the learned I-Additional District Munsif, Tiruchirapalli to expedite the trial in O.S.No.556 of 2012 and dispose of the same within a stipulated period.

2. The learned counsel appearing for the revision petitioners would submit that the respondents / plaintiffs have filed the suit for permanent injunction against the revision petitioner / defendant. He would further submit that though the suit was filed by the respondents / plaintiffs in the year 2012, till date the respondents / plaintiffs did not proceed with the trial and the Court below also has been adjourning the suit without any valid reason and hence, he has come up with this civil revision petition for the aforesaid prayer.

3. Since this petition is filed for a limited relief of early disposal, no notice need be sent to the respondents.
