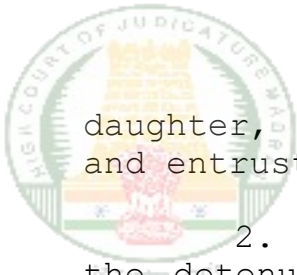

The petitioner, who is the father of detainee, has moved this petition for a direction to the 5th Respondent to produce his



daughter, namely, Parvathi, aged about 17½ years before this Court and entrust her custody to the petitioner.

2. According to the petitioner, on an earlier occasion, when the detinue was found missing, a Habeas Corpus Petition was filed before this Court in HCP(MD)No.1363/2016. Thereafter, on 19.04.2017, the respondent police produced the detinue Parvathi before this Court and this Court directed the respondent police to send the detinue to Sakthi Vidiyal Home, Muthupatti, Alagappan Nagar, Madurai, the 5th respondent herein. Accordingly, the detinue was sent to the Sakthi Vidiyal Home and she is staying in the said Home till date. However, on coming to know that the detinue is willing to be along with the petitioner herein, this petition has been filed.

3. Today, the detinue has been produced before this Court by the 5th respondent.

4. On being enquired with the detinue, she has expressed her willingness to go along with her parents, who are present before this Court.

5. Recording the fact that the detinue, namely, Parvathi, is a minor and also the fact that she is desirous to accompany her parents, this Habeas Corpus Petition is disposed of.
