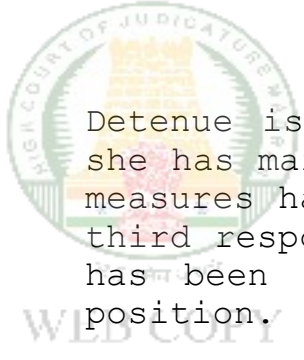

This Habeas Corpus Petition has been filed by the petitioner, seeking production of his daughter, namely, Yogapriya, aged 23 years.

2.The petitioner and his wife are present. The detainee, daughter of the petitioner, is produced by the second respondent.



Detenue is accompanied by the third respondent, whom she informs she has married and towards registration of the said marriage due measures have been taken. She informs her intent to accompany the third respondent and not return to the parent home. The petitioner has been informed of the same and he is reconciled to such position.
