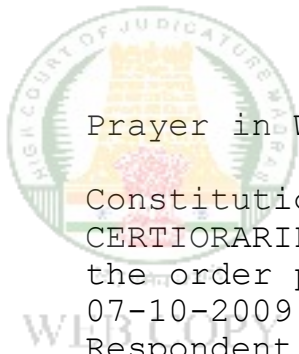

Prayer in WP (MD). 2945/ 2010 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF CERTIORARI MANDAMUS, to call for the documents pertaining to the order passed by the 1st Respondent in O.Mu.No.15805/04/J3, dated 01-10-2009 and the consequential order passed by the 3rd Respondent vide No.Na.Ka.No.2991/09/H1, dated 25-01-2010 and quash the same and insofar as petitioner consequently direct the Respondents to regularize the service of the petitioner from the date of appointment.



Prayer in WP(MD). 2944/ 2010 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a WRIT OF CERTIORARIFIED MANDAMUS, to call upon the documents pertaining to the order passed by the 1st Respondent in O.Mu.No.15805/04/J3, dated 07-10-2009 and the consequentially order passed by the 3rd Respondent vide No.Na.Ka.No.2991/09/H1, dated 25-01-2010 and quash the same in so far as petitioner concerned and may consequential direct the Respondents to regularize the service of the petitioner from the date of appointment.
