Prayer in WP(MD). 22840/ 2016 :

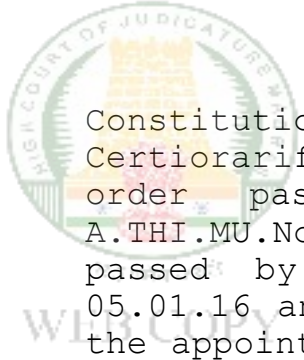
