F2/2175/2010, dated 22.07.2014 relating Shop No. 15 and quash the same and consequently direct the respondent to assess the real status of the building in which disputed shop in question is situated and ascertain as to whether it requires demolition and reconstruction and further to direct the respondent to grant sufficient time to vacate the premises in case if they comes to the conclusion based on materials that the said building requires demolition and reconstruction and further direct the respondent to accord priority to the petitioner in letting out the shop after such demolition and reconstruction.
