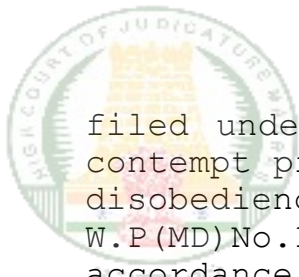

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus to direct the Respondent No.1 to 7 to remove the illegal encroachment by the Respondent No.9 and 11 from the land in Narasingam 4th bit Survey Number 147/1B comprising 2 acres and 82 cents, which allotted to the Y.Othakadai Government Higher Secondary School at Ulaganeri, Narasingam Panchayat, Madurai District and to direct the Respondent No.1 to 7 to construct boundary wall around to the said school within the time stipulated by this Honble Court.
