4.Considering the aforesaid submissions, the second respondent is directed to consider the representation submitted by the petitioner, dated 06.12.2017 and dispose of the same at early by considering the decision of the Hon'ble Supreme Court of India in the case of **Church of God (Full Gospel) in India Vs. K.K.R, Majestic Colony Welfare Association and Ors**, reported in 2001 - 1 - L.W. (Cr1.) 233.

5.With the aforesaid observations, this writ petition is disposed of. No costs.
