2.This Writ Petitioner seeks issuance of a Writ of Mandamus directing the respondents to remove encroachment made in Survey No.1662/19 (Old Survey No.517) situated at Maraneri Village, Sivakasi Taluk, Virudhunagar District based on the petitioner's representation dated 28.03.2018.

3.Learned Additional Government Pleader produced a communication dated 23.05.2018.

4.Communication dated 23.05.2018 informs that such encroachment has already come to the notice of the authorities concerned and they have acted appropriately in the matter.



5. In the circumstances, there is no need to entertain this Writ petition, which seeks relief against fifth respondent by way of public interest litigation. Accordingly, this Writ petition shall stand dismissed. No costs.
