Heard the learned counsel on either side.

2.The petitioner is employed in the third respondent College. The petitioner has been suspended by an order dated 22.01.2018. The order of suspension is questioned on the ground that there is no resolution passed by the college Committee. This contention raised



by the writ petitioner is not controverted by the learned counsel appearing for the third and fourth respondents. In fact, the learned counsel for the third and fourth respondents would submit that they shall withdraw the order of suspension impugned in this writ petition.
