Prayer in WP(MD)No.180 of 2018 : This Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, to call for the records pertaining to the impugned communication in O.Mu.No.2998/A2/2017, dated 10.2017 signed on 12.10.2017 on the file of the respondent No.3 and the consequential communication in O.Mu.No.334/A2/2017, dated 25.10.2017 on the file of the respondent No.4 and quash the same as illegal and consequently to direct the respondents No.3 and 4 to approve the appoint of the petitioner as B.T.Assistant (Mathematics) with effect from the date of appointment on 08.06.2017 with all monetary and service benefits within a stipulated time.



Prayer in WP(MD)No.181 of 2018 : This Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorari Mandamus, to call for the records pertaining to the impugned communication in O.Mu.No.2997/A2/2017, dated 12.10.2017 on the file of the respondent No.3 and the consequential communication in O.Mu.No.231/A2/2017, dated 25.10.2017 on the file of the respondent No.4 and quash the same as illegal and consequently to direct the respondents No.3 and 4 to approve the appointment of the petitioner as Secondary Grade Teacher with effect from the date of appointment on 07.08.2017 with all monetary and service benefits within a stipulated time.
