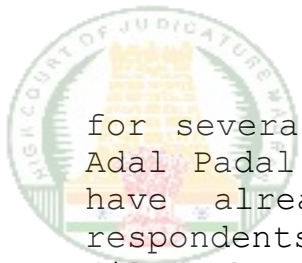

2.Heard, Mr.B.Mohankumar, learned counsel appearing for the petitioner and Mr.N.Shanmugaselvam, learned Additional Government Pleader appearing for the respondents.

3.The learned counsel appearing for the petitioner has submitted that the petitioner is one of the committee members of the said Temple. The villagers are conducting the Adal Padal Programme



for several years and this year, they have decided to conduct the Adal Padal Programme on 13.02.2018 and 14.02.2018 and for that they have already given a representation dated 22.01.2018 to the respondents, but, sofar, no order has been passed. Hence, he has filed the present writ petition.
