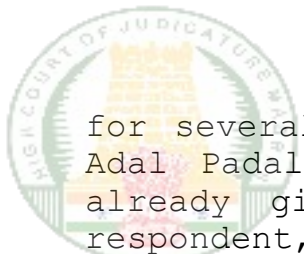

3.The learned counsel appearing for the petitioner submitted that the petitioner is one of the committee members of the said Temple. The villagers are conducting the Adal Padal Dance Programme



for several years and this year, they have decided to conduct the Adal Padal Dance Programme on 09.02.2018 and for that they have already given a representation dated 30.01.2018 to the second respondent, but, sofar, no order has been passed. Hence, he has filed the present writ petition.
