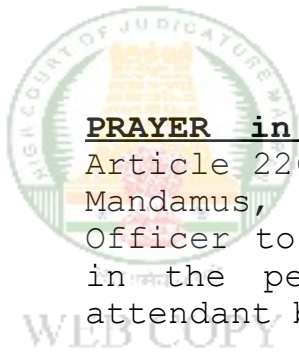

4.The petitioner/School Management appointed non teaching staffs. The petitioner appointed the following non teaching staffs:-
