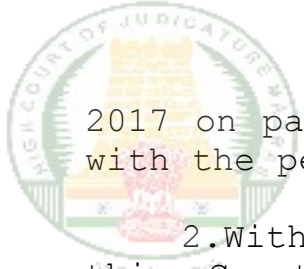
Prayer: Writ Petition filed under Article 226 of Constitution of India, to issue a Writ of Mandamus to direct the first respondent ie., the Principal Secretary to Government, Revenue Department, Chennai to pass appropriate orders on the petitioner's representation dated 25.09.2017 regarding grant of exemption from the operation of A(ii) of Annexure III to Rule 7 of the Tamil Nadu Revenue Subordinate Service Rules so as to include her name in the Deputy Tahsildar list of the year 2017 on par with her colleagues who wrote TNPSC examination along with the petitioner, within a specified time.
