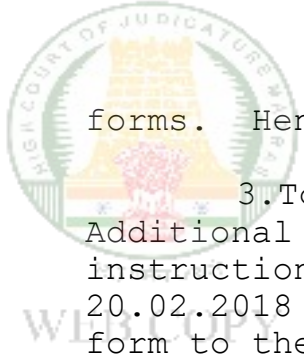
Prayer: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus, directing the respondents 1 to 3 to issue tender notice and to issue tender schedule to the petitioner for the work selected in the Vagaikulam Village Panchayat, Ramanathapuram and other Village Panchayats in Ramanathapuram under 14th Finance Commission and further direct the respondent to strictly adumbrate procedures prescribed in the Tamil Nadu Transparency in Tenders Act and Rules.

ORDER

This writ petition has been filed seeking a direction to the respondents to issue tender notice and tender schedule to the petitioner in respect of various water works in the Kadaladi Panchayat Union.

forms. Hence, the present writ petition has been filed.

4. Recording the above submission, this writ petition is closed. The third respondent is directed to issue tender form to the petitioner enabling to participate in the tender. No costs. Consequently, connected miscellaneous petition is closed.
