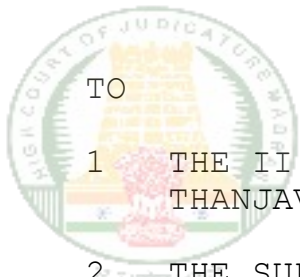
The interim order, dated 22.2.2018, under which, the suspension of sentence has been extended, till 5.3.2018, is further extended until further orders.
