life convict undergoing life imprisonment at Central Jail at Trichy. The petitioner's son has been inside Jail for more than 12 years. Therefore, the petitioner made a representation to the first respondent seeking for pre-mature release.

In view of the limited relief sought for by the petitioner, there shall be a direction to the first respondent to consider the representation, dated 11.02.2018, made by the petitioner in accordance with law and pass appropriate orders within a period of four weeks from the date of receipt of a copy of this order.
