O R D E R

This writ petition has been filed to direct the respondent to grant permission to the petitioner to conduct the 53 years Kabadi event on 23.02.2018 at 08.01 PM to 25.02.2018 at 11.00 at Kaliyamman Kovil Thidal, Mangammalpuram Village, Anbil, Lalgudi Taluk, Trichy District as per the petitioner's representation dated 19.02.2018.

2.Heard, Mr.P.Ganapathi Subramanian, learned counsel appearing for the petitioner and Mr.N.Shanmuga Selvam, learned Additional Government Pleader appearing for the respondent.

3.The learned counsel appearing for the petitioner submitted that the petitioner is one of the Villagers of the said Village. The villagers are conducting Kabadi Event for the past several years and this year, they have decided to conduct the Kabadi Event from 23.02.2018 to 25.02.2018 and for that, they have already given a representation dated 19.02.2018 to the respondent, but, sofar, no order has been passed. Hence, he has filed the present writ petition.

4.The learned Additional Government Pleader appearing for the respondent submitted that there is a law and order problem and hence the petitioner's representation is kept pending.



5.Considering the aforesaid submissions, the respondent is directed to consider the representation submitted by the petitioner, dated 19.02.2018 and dispose of the same at early. At the time of passing order, the respondent has to keep in mind the decision of the Hon'ble Supreme Court of India in the case of Church of God (Full Gospel) in India Vs. K.K.R, Majestic Colony Welfare Association and others, reported in 2001 - 1 - L.W. (Cr1.) 233.

6.With the aforesaid observations, this writ petition is disposed of. No costs.
