This writ petition has been filed to direct the respondent to grant permission to the petitioner to conduct Adal Padal Programme on 24.02.2018 as part of the Arulmighu Mottaiyanswamy Kovil festival celebration at Mettuchavadi, Ladanenthall, Thiruppuvanam Taluk, Sivagangai District.

2.Heard, Mr.SP.Vijay Nivas, learned counsel appearing for the petitioner and Mr.B.Bhagawathi, learned Government Advocate appearing for the respondent.

3.The learned counsel appearing for the petitioner submitted that the petitioner is one of the Villagers of the said Village. The villagers are conducting Adal Padal Programme for the past several years and this year, they have decided to conduct Adal Padal Programme on 24.02.2018 and for that, they have already given a representation dated 19.02.2018 to the respondent, but, sofar, no order has been passed. Hence, he has filed the present writ petition.



4.The learned Government Advocate appearing for the respondent submitted that there is a law and order problem and hence the petitioner's representation is kept pending.
