This writ petition has been filed to direct the respondent herein to grant permission to conduct Adal Padal dance programme on 03.03.2018 at night in pursuance of the Kumbabishekam of the Arulmighu Sonai Muthiah Swami and Muthu Vinayakar Thirukoil situated at Eluvanampatty Village, Nilakottai Taluk, Dindigul District.

2.Heard, Mr.Vellaichamy, learned counsel appearing for the petitioner and Mr.V.Anand, learned Government Advocate, appearing for the respondent.

3.The learned counsel appearing for the petitioner has submitted that the villagers are conducting the Adal Padal dance programme on 03.03.2018 and for that, they have already given a representation dated 16.02.2018 to the respondent, but, sofar, no



order has been passed. Hence, he has filed the present writ petition.

4.The learned Government Advocate appearing for the respondent has submitted that there is a law and order problem and hence, the petitioner's representation is kept pending.

5.Considering the aforesaid submissions, the respondent is directed to consider the representation submitted by the petitioner, dated 16.02.2018 and dispose of the same at early. At the time of passing order, the respondent has to keep in mind the decision of the Hon'ble Supreme Court of India in the case of *Church of God (Full Gospel) in India Vs. K.K.R, Majestic Colony Welfare Association and Ors*, reported in 2001 - 1 - L.W. (Crl.) 233.

6.With the aforesaid observations, this writ petition is disposed of. No costs.
