Prayer in Crl.M.P (MD) No.5885 of 2016:

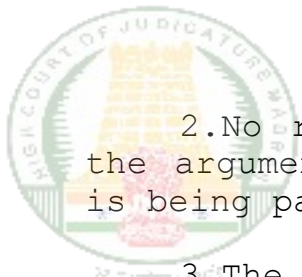
