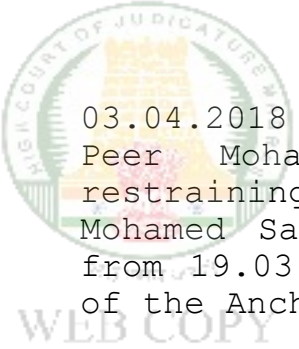

2.Today when the matter is taken up for hearing, learned Standing Counsel appearing for the first respondent submitted that the third respondent has handed over the management to the second respondent, the Superintendent of Wakfs, Madurai and he is taking steps to conduct the said festival.

3.In view of the above said submission, nothing survives for further adjudication, in this writ petition. Accordingly, the writ petition is closed. No costs. Consequently, W.M.P(MD)No.4610 of 2018 is also closed.
