Prayer : Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus to direct the respondents to refix the petitioner's salary and basic pay on the basis of his last pay drawn in R.C.Middle School, Panankudi, Kallal Division, Sivagangai District from 05.02.2007 in the light of the Government Order in G.O.Ms.No.1072 (Personnel and Administrative Reforms (FR.III) Department dated 31.10.1986 and based on the similar proceedings of the AEEO Vellore in Na.Ka.No.594/A1/2011 dated 28.07.2011 by considering the Appeal dated 23.02.2018 made by the petitioner within the same stipulated by this Court.
