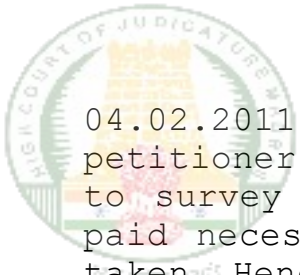

ORDER

Thereafter, on 20.12.2017, the petitioner has filed an application before the respondents 2 and 3 to survey the above property and fix boundaries and he has also paid necessary fee for the same. But, so far no action has been taken. Hence, the petitioner has filed this writ petition.
