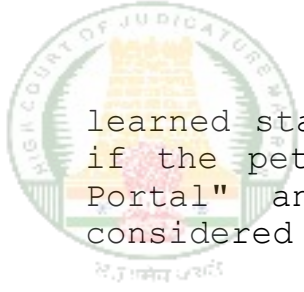

Recording the submission made by the learned counsel for the respondents 2 and 3, the petitioner is granted liberty to make online application through "Vidyalakshmi Portal" seeking for educational loan and on receipt of such application, the second respondent shall pass favourable orders disbursing the educational loan to the petitioner herein, if the application is otherwise in order. Such an exercise shall be completed within a period of two weeks from the date of receipt of such application.
