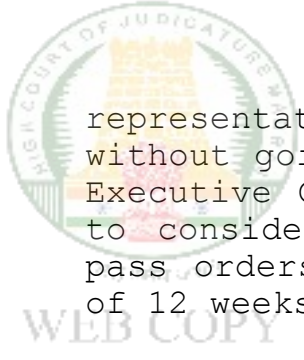

ORDER

According to the Writ Petitioner, Sree Uthandakalai Thirukovil situated at Karivalamvanthanallur is a family deity of ten community people of the Karivalamvanthanallur Village. It was founded by the forefather of 10 community people. Now the second respondent sealed the temple as the same belongs to H.R. & C.E department. In the above circumstances the petitioner submitted a representation to the second respondent on 31.01.2018 requesting the respondent to furnish the documents relating to the above said temple. Since so far no order has been passed, the present writ petition has been filed by the petitioner.
