Prayer in W.P(MD)No.5549 of 2018: Petition filed under Article 226 Constitution of India to issue a Writ of Mandamus, to direct the respondents herein to regularise the occupation of the petitioners house site bearing Survey No.49 of an extent of 2 cents bearing door 3/82 North Kadarkarai Kudiyeruppu Pudukudi Thondi Ramanathapuram District and issue appropriate patta to the petitioner by considering the last representations of the petitioner dated 27/02/2018 within the time.

COMMON ORDER

These writ petitions have been filed seeking direction to the respondents to regularise the occupation of the petitioners in S.Nos.73/1 and 49 and to issue patta to the petitioners by considering their representation dated 27.02.2018.

2.According to the petitioners, they are residing in S.Nos.73/1 and 49 survey numbers in North Kadarkarai, Kudiyeruppu, Pudukudi, Thondi, Ramanathapuram District for more than 70 years by putting up construction in the lands. In the above circumstances, the petitioners filed an application dated 09.03.2018 seeking patta to the petitioners before the first respondent. Since no order has been passed, the present writ petition has been filed.

3.Considering the facts and circumstances of the case, this Court, without going into the merits of the case, directs the first respondent to consider the application of the petitioners dated 09.03.2018 and pass appropriate orders, on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

4.With the above direction, the writ petitions are disposed of. No costs.
