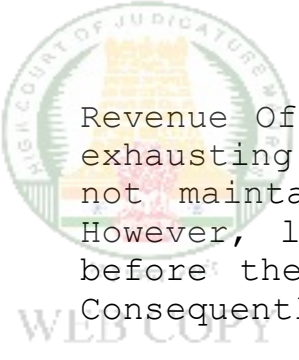

ORDER

This writ petition has been filed challenging the order passed by the The Tahsildar, Trichy West, Trichy District, the fourth respondent herein rejecting the petitioner's application for grant of patta. As against the said order, there is appeal remedy available before the Revenue Divisional Officer and thereafter a revision is also available before the District



Revenue Officer. The petitioner has approached this Court without exhausting such appeal remedy and therefore, the writ petition is not maintainable. Accordingly, the writ petition is dismissed. However, liberty is granted to the petitioner to file an appeal before the Appellate Authority, if he is so advised. No costs. Consequently, W.M.P(MD)No.5367 of 2018 is closed.
