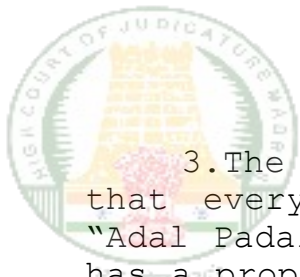

Likewise, in this year also, the petitioner has a proposal to conduct "Aadal Padal" programme on 14.01.2018 and for that, he gave a representation on 06.01.2018 to the second respondent, but, so far, the said representation has not been considered by the second respondent.

4.The learned Government Advocate has submitted that the respondents will consider the petitioner's representation and pass appropriate orders.

5.Considering the aforesaid submission, the respondents are directed to consider the representation submitted by the petitioner dated 06.01.2018 and dispose of the same on or before 13.01.2018.
