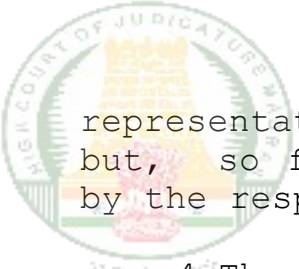

2.Heard, Mr.K.Dhanasekar, learned counsel appearing for the petitioner and Mrs.Bhagavathi, learned Government Advocate appearing for the respondents.
