Upon receipt of the representation, the third respondent is directed to review the order of suspension dated 15.02.2018 and pass appropriate orders on merits and in accordance with law within a period of eight weeks from the date of receipt of a copy of this order.

4.Accordingly, the writ petition stands disposed of. No costs. Consequently, connected miscellaneous petition is closed.
