This writ petition has been filed by the petitioner to direct the respondent to grant permission to perform the programs such as Adal Padal festival on 30.03.2018 at night 09.00 pm to 12.00 am at Arulmigu Sri Kalamman Thirukovil situated at Perumalkovilpatti, K.Ayyapatti Post, Kombaipatti Village, Dindigul East Taluk, Dindigul District and to provide adequate police protection based on the petitioner's representation dated 20.03.2018.

2.Heard Mr.A.Chandrakumar, learned counsel appearing for the petitioner and Mr.V.Anand, learned Government Advocate appearing for the respondent.

3.The learned counsel appearing for the petitioner has submitted that the petitioner is one of the Villagers of the said Village. The villagers are conducting the "Adal Padal" for the past several years and this year, they have decided to conduct the "Adal Padal" on 30.03.2018 and for that, they have already given a representation dated 20.03.2018 to the respondent, but, sofar, no



order has been passed. Hence, he has filed the present writ petition.

4.The learned Government Advocate appearing for the respondent has submitted that there is a law and order problem and hence, the petitioner's representation is kept pending.

5.Considering the aforesaid submissions, the respondent is directed to consider the representation submitted by the petitioner, dated 20.03.2018 and dispose of the same at early. At the time of passing order, the respondent has to keep in mind the decision of the Hon'ble Supreme Court of India in the case of *Church of God (Full Gospel) in India Vs. K.K.R, Majestic Colony Welfare Association and Ors*, reported in 2001 - 1 - L.W. (Cr1.) 233.

6.With the aforesaid observations, this writ petition is disposed of. No costs.
