Therefore, he has given representation in this regard on 21.08.2017. The petitioner moved the second respondent in this regard. A formal enquiry was also conducted. But then final orders are yet to be passed.

4.The second respondent is directed to pass final orders on merits and in accordance with law in this regard in any event within a period of six weeks from the date of receipt of a copy of this order.

5.The Writ Petition is disposed of accordingly. No costs.
