Prayer: Writ Petition filed under Article 226 of Constitution of India, to issue a Writ of Mandamus, to direct the respondents herein to accord necessary permission and also provide adequate police protection during the conduct of the Annadanam function and also other related functions of the Sri Samayapuram Mariamman temple Ther Thiruvizha (Car Festival) being held on 15th and 16th April 2018 on the basis of the petitioner representation dated 16.03.2018.

O R D E R

This writ petition has been filed to direct the respondents to grant permission and adequate police protection to 'Annadanam function and also other related functions' in connection with the 'Ther Thiruvizha (Car Festival)' of "Sri Samayapuram Mariamman Temple" being held on 15th and 16th April 2018 pursuant to the representation dated 16.03.2018.

2.Heard, Mr.B.Jameel Arasu, learned counsel appearing for the petitioner and Mr.V.Anand, learned Government Advocate appearing for the respondents.

3.The learned counsel appearing for the petitioner has submitted that the villagers are celebrating the aforesaid temple festival every year and this year also, they have decided to



conduct 'Annadanam function and also other related functions' on 15.04.2018 and 16.04.2018 in connection with the aforesaid temple festival and for that, they have already given a representation dated 16.03.2018 to the second respondent, but, sofar, no order has been passed. Hence, he has filed the present writ petition.

4.The learned Government Advocate appearing for the respondents has submitted that there is a law and order problem and hence, the petitioner's representation is kept pending.

5.Considering the aforesaid submissions, the second respondent is directed to consider the representation submitted by the petitioner, dated 16.03.2018 and dispose of the same at early. At the time of passing order, the second respondent has to keep in mind the decision of the Hon'ble Supreme Court of India in the case of **Church of God (Full Gospel) in India Vs. K.K.R, Majestic Colony Welfare Association and Ors**, reported in 2001 - 1 - L.W. (Cr1.) 233.

6.With the aforesaid observations, this writ petition is disposed of. No costs.
