This writ petition has been filed to direct the respondents to grant permission and necessary police protection to perform the cultural programme (ie.,) Adal Padal Dance programme on 07.04.2018 at 07.00pm to 11.00pm., in the festival of Arulmigu Sri Petchiamman Thirukovil at Munandipatti, Dhevaram Uthamapalayam Taluk, Theni District.

2.Heard, Mr.V.Manikandan, learned counsel appearing for the petitioner and Mr.B.Bhagawathi, learned Government Advocate, appearing for the respondents.

3.The learned counsel appearing for the petitioner has submitted that the villagers are conducting the programme (ie.,) 'Adal Padal' 07.04.2018 at 07.00pm to 11.00pm., in the festival of Arulmigu Sri Petchiamman Thirukovil at Munandipatti, Dhevaram Uthamapalayam Taluk, Theni District and for that, they have already given a representation dated 16.03.2018 to the 2nd respondent, but, <https://hcservices.ecourts.gov.in/hcservices/> solar, no order has been passed. Hence, he has filed the present writ petition.



4.The learned Government Advocate appearing for the respondents has submitted that there is a law and order problem and hence, the petitioner's representation is kept pending.

5.Considering the aforesaid submissions, the 2nd respondent is directed to consider the representation submitted by the petitioner, dated 16.03.2018 and dispose of the same at early. At the time of passing order, the respondent has to keep in mind the decision of the Hon'ble Supreme Court of India in the case of Church of God (Full Gospel) in India Vs. K.K.R, Majestic Colony Welfare Association and Ors, reported in 2001 - 1 - L.W. (Crl.) 233.

6.With the aforesaid observations, this writ petition is disposed of. No costs.
